**Note 1 Enlisted Contractors with DCWE:-**

1. Following documents to be received in hard copy in this office by the date and time of bid opening (Cover No.1) positively failing which the firm shall be rendered ineligible for opening of financial bid.

- (a) Cost of tender
- (b) Amount of earnest money
- (c) Eligibility documents – The following PQ documents alongwith all enclosures and undertaking.

2. Cost of tender documents shall be non-refundable. Application not accompanied by requisite value in terms of DD/Banker's cheque towards cost of Tender EMD & undertaking shall not be considered. However, DD/ Banker's cheque against EMD shall be returned to the applicants whose cover No. 2 (Price bid by e-mode) is not opened. Please note that cover No. 2(price bid by e-mode) will be opened only in respect of qualified and eligible firms who fulfill the eligibility criteria according to their PQ bid submitted in Cover No 1 (Cost of tender, EMD,applications, temporary composite enlistment documents & PQ criteria). Documents along with Cover-1 received without EMD in original as required will not be Qualified.

3. The bidder shall submit a certificate for **Acceptance of Terms & Conditions of Tender** as attached in **Annexure “B” (Refer proforma enclosed as Annexure “B”**

4. Condition of Banned Business-Employer or any Central/State Government Department or Central/State Autonomous Body or Central/State Public Sector Undertaking or any Other Government entity or local body should not have suspended /debarred / blacklisted (either permanently or temporarily) the tenderer from participating in any bid or doing any business, as on last date of submission of the bid. No Contract of the tenderer executed either individually or in a JV / Consortium should have rescinded /terminated by any Central / State Government Department or Central / State Autonomous Body or Central / State Public Sector Undertaking or any Other Government entity or local body after award during previous three years (from the last date of submission of the Bid) due to non-performance of Tenderer(**Annexure–‘C’**)

4. **Bidding capacity** of firm shall be submitted along with the Technical bid.As per the formulae/procedure issued by CPWD:-

The Bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = [A \times N \times 2] - B$$

Where,

A = Maximum value of construction works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of work for which this bid has been invited.

B = Value of existing commitments and ongoing works to be completed during the period of completion of work for which this bid has been invited.

The documents in support of above shall be submitted along with the tender.

**Note: -**

(a) The bidding capacity of the contractor obtained from above formulae should be equal to or more than the estimated cost of the work put to tender.

(b) In case the tenderer is lowest, the tendered amount will be considered as work load of the firm for the purpose of calculating the bidding capacity in subsequent tenders issued by CCEs. The subsequent tenders will be considered if the firm meets the bidding capacity criteria.

(c) The bidder shall submit the Bidding Capacity as per the formula above along with supporting documents i.e.. copies of LOI/Work Order for all work specified as per formula for bidding capacity.

(d) Bidding capacity will be evaluated as on date of opening of tender and qualification / disqualification will be decided accordingly.

8. The firm should not have incurred any loss (profit after tax should be positive) in more than two years during the last 07 Seven consecutive years ending 31st March 2022 of previous financial year, duly audited and certified by the Chartered Accountant shall be submitted. Income Tax Returns or any other authentic documents shall be submitted showing that the firm have not incurred any loss (Refer: proforma enclosed as **Annexure – ‘A’**).

9. The bidder to submit copies of Eligibility Documents, Copy of EPF, ESI & GST registration application. In case EPF and ESI are not applicable to the company, this aspect may be intimated by the letter on company letter head failing which Price bid by e-mode (cover 2) will not be opened.

10. Enlistment letter in eligible class/category to be attached.

11. Self declaration to be submitted for ongoing litigations.

12. The Accepting Officer shall receive applications (Cover No 1) upto the last date & time of bid submission/ extended date of bid submission as applicable and as mentioned below.

13. The earnest money of unsuccessful bidders will be returned to them without any interest within 15 working days after opening of Price Bid.
14. Submitted bid doesn't constitute any guarantee for opening of Price bid of bidder. Opening of quoted Price bid will be decided based on eligibility criteria given in NIT. The Bidder will be informed regarding non-opening of their bids with reasons. The Bidder if he desires, may appeal to the next higher Engineer Authority viz DCW&E, New Delhi with copy to the Accepting Officer within 07 (seven) days from the date of opening of cover 1. The decision of the next higher Engineer Authority shall be final and binding. Bidder shall not be entitled for any compensation whatsoever for rejection of his Price bid.
15. In order to participate in tendering, bidder has to upload the Scanned/ Xerox Copy of Eligibility Documents, Enquiry Documents and Enlistment letter along with enclosures, Provident Fund Code Number, ESI & GST Registration and these documents are to be submitted by the bidder in cover No. 1.

Information will be shared verbally only. No representation shall be entertained later. Conditional application will be rejected without assigning any reason.

18. The documents shall be signed by owner of the firm or authorised signatory of firm. The authorisation letter duly signed by notary shall be submitted.
